# AMA ASSOCIATION NOTES TO THE FINANCIAL STATEMENTS For the period from January 1, 2019 As of December 31, 2019

### 1. BACKGROUND, LEGAL SITUATION AND LEGAL REPRESENTATION

The AMA Association emerged in 2013 as a youth group made up of adolescent and young leaders between the ages of 14 and 30, who live in rural communities and marginal urban areas in southern Petén.

In 2013, AMA participated in the call for the Ola Joven program of the Central American Fund for Women -FCAM-, with the proposal of the project "Activate Joven Mujer". Through which AMA was benefited with a seed capital fund, which was transferred and managed directly by the group during the execution of the project in 2014.

As a result of the first experience and the good results achieved, AMA in alliance with the FCAM implemented the projects: "Activate Joven Mujer Phase II", in 2015; the project "Organizational strengthening as a strategy for the defense of the rights of young women in southern Petén Phase I and II" in 2016 and 2017; the projects "Strengthening of the pilot program for Personal Development and Professional Improvement (PACE for its acronym in English)" and the project "Take Sides Against Violence" both executed in 2018, and in 2019 the project "Take Sides Against Phase II Violence".

In collaboration with the Central American and Mexican Youth Fund -CAMY Fund-from 2015 to 2018, he executed the Love Me and Protect Me from Pregnancy project "Youth Leadership for the prevention of pregnancies in the south of Petén Phase I, II and III".

In recognition of their altruistic work, the AMA Association in 2016 was awarded the "With and For Girls" Collective Award from the Stars Foundation, which ran from 2017 to 2018, in 2019 they financed the project "Strengthening and political incidence of municipal networks for the protection of children and adolescents in the department of Petén, Guatemala"

As of 2017, the Women of the South Fund trusts AMA and decides to finance the project Know, Act and Demand "Promotion and Defense of Sexual and Reproductive

Rights for the Prevention of Pregnancies and Sexual Violence in Girls and Adolescents in the Area South of Petén", executing its Phase I, II and III from the year 2017 to the month of February of the year 2020.

Starting in 2018, AMA began an alliance with the Women Win organization, who are currently financing the "Play It Forward / PACE Girls" and "Personal Development and Professional Improvement (PACE)" projects, both in their second phase of execution.

In the same year, 2018, AMA began its relations with the Global Fund for Women (Global Fund for Women) and the Global Fund for Children (Global Fund for Children), with whom it currently has a relationship of partners.

With the implementation of these projects, AMA has promoted the democratic participation and leadership of women and youth, human rights, sexual and reproductive rights, promoted the prevention of pregnancies and sexual violence in girls and adolescents, the implementation of comprehensive education in sexuality-EIS- in the educational system and the inclusion of women and youth in the local development processes of the communities of the South of Petén.

The work implemented has been carried out with the full participation of adolescents and young people, local institutions and the organized civil sector. This process has made it possible to visualize some problems of an endemic and structural nature, such as the little recognition of the democratic participation of women and youth and the high rate of sexual violence -VS- and of pregnancies and in girls and adolescents.

The implementation of these projects have allowed promoting and strengthening spaces for political incidence such as the "Prevention with Education Technical Table" of Petén, which is a space that brings together decision makers from the Ministry of Health, Ministry of Education-MINEDUC- and civil society organized to promote and verify the progress of the Letter-Agreement "Prevent with Education 2016-2020", which is a multisectoral response to respond to the high rate of pregnancies and violence in Guatemalan girls and adolescents, which which has been carried out through the implementation of the 2018 and 2019 Strategic Plans and currently in the 2020 Plan of the aforementioned Board.

AMA has also promoted the creation and implementation of the 2018, 2019 and 2020 Strategic Plans of the District Technical Tables "Prevent with Education" of the South East, South West and North Petén, which presents a direct response by the

collaborators of the Ministry of Education and Ministry of Health to the aforementioned problems, this always with multisectoral support.

AMA has strategic alliances with civil society organizations, government institutions and the media to fulfill its objectives, which is why it has cooperation agreements with the MINEDUC of Petén, the Petén Suroriental Health Area, the community radio station U'tan Kaj and Shekina Evangelical Christian radio, to promote sexual and reproductive rights, gender equality, prevention of pregnancies and sexual violence in girls and adolescents, democratic participation of women among others.

AMA, in alliance with Radio U'tan Kaj, has been promoting since 2014 and in alliance with Radio Shekina since 2017, the bilingual Spanish-Maya Q'eqchí radio program "El ABC de la Sexualidad" which allows socializing the themes that AMA promotes to the rest of the population and especially that of indigenous and rural communities.

AMA is currently part of platforms for dialogue and political advocacy such as AMA is part of the Women's Health Network of Latin America and the Caribbean - RSMLAC-, the Local Derivation Network for Victim Care in Southern Petén and the Municipal Development Council de Poptún -COMUDE-, in which it directly influences decision makers in order to implement actions that provide immediate responses to the problems most felt by women and youth.

On May 27, 2016, it was legally constituted as ASOCIACION AMA with the purpose of having greater autonomy and access to financing sources, an activity that is part of the organizational strengthening project financed by FCAM and according to its Constitution Act, with the objective of Charity and social and humanitarian support, aimed at those areas of the communities in which poverty and extreme economic poverty are detected. In addition, it will ensure the well-being and development of Children, Adolescents, youth, women and the community as a whole.


The presidency and Legal representation of the AMA Association is exercised by Ms. LESLIE MARILY MEJIA CASTELLANOS, according to appointment dated August 8, 2016, the same position that was extended with appointment dated January 9, 2019.

The AMA Association's Vision is to be a leading and recognized organization that promotes the comprehensive development of women, children and youth, through programs aimed at transferring skills and strengthening attitudes of leadership, democratic participation and economic development, sustainable, with emphasis on the promotion and defense of human rights and sexual and reproductive rights of girls, adolescents and young people in the department of Petén.

And as Mission, To be a non-profit organization that promotes and encourages leadership, democratic participation, sustainable economic development and access to comprehensive education on sexuality and the sexual and reproductive rights of women, children and youth of the department of Peten. And his office is located on the 4th. Calle 5-09, Barrio el Centro, zone 1 of the municipality of Poptún, Petén.
