# AMA ASSOCIATION NOTES TO THE FINANCIAL STATEMENTS For the period from January 1, 2024 As of December 31, 2024

### 1. BACKGROUND, LEGAL STATUS AND LEGAL REPRESENTATION

In 2011, the idea of creating an organization dedicated to supporting the development of adolescent girls and young women in the southeastern Petén region, based on local needs, emerged. This initiative took shape in 2012 under the name Agrupación Juvenil de Mujeres Activas (Youth Group of Active Women), from which the name AMA is derived. This term became the name of the organization when the legal status of the Association was established in 2016. The term AMA ceased to be an acronym and became the organizational name upon its official registration. That same year, AMA received the internationally recognized "With and For Girls" award, granted by a group of eight donors under the coordination of the Stars Foundation. 1, an England-based organization that aims to improve the lives of girls.

Through its legal constitution, the group adopts the status of a non-profit association based on the Guatemalan Civil Code, the Procedural, Civil and Commercial Code, and the Law on Non-Governmental Organizations for Development.2 and its Regulations, as well as the Regulations for the Registration of Civil Associations. Thus, AMA becomes "a private, non-profit, non-religious, apolitical, social, cultural, educational, humanitarian, social assistance and service, and comprehensive community development organization," whose objective is "charity and social and humanitarian support directed toward those areas of communities where poverty and extreme economic poverty are detected," precepts established in the organization's Statutes.

These Statutes establish that the Association will ensure "the well-being and development of children, adolescents, youth, women, and the community as a whole; as well as comprehensive security, citizen security, coexistence, youth, comprehensive development, human rights, social development, general and sustainable environmental development, and violence prevention from every

perspective." Its headquarters are located in the municipal seat of Poptún, Petén, and in its first phase, directly serving the municipalities in the southeast of the department: San Luis, Poptún, Dolores, El Chal, and Santa Ana. In its second phase, AMA expands its coverage to the other subregions of Petén, but only through training activities for institutional staff to achieve a cascading impact.

By the end of 2021, AMA presents an organizational lifeline that can be divided into stages, with a five-year time span between each phase. Each phase depicts organizational changes, differentiating between management transitions.

The Founding Stage consisted of the creative actions, from forming a Youth Group of Active Women to becoming an Association, as a legally established organization, which occurred between 2012 and 2016, when the Central American Women's Fund (FCAM) granted them funds that included the completion of the necessary legal procedures for their registration, as part of the Project "Organizational Strengthening as a Strategy for the Defense of the Rights of Young Women in Southern Petén."

Having established its legal status has been a key factor in directly managing funds. Since 2017, AMA has increased its number of partners and projects, thereby expanding its involvement. This dynamic has resulted in the Association's positioning and recognition by state institutions and other organizations in the subregion where it operates.

With this change in legal status, a new phase began, spanning from 2017 to 2021. This phase saw the development of administrative and financial instruments, internal policies, and technical tools, while increasing the number of projects and cooperation projects. Some of these projects established bonds of trust, leading the former to refer AMA to other cooperation agencies, opening up opportunities for the search for new funding and marking a major step in its organizational growth.

A review and update of the Organizational Development Plan, as part of the internal reflection process carried out in September 2021, led the organization to promote the update of its strategic plan, given the need to efficiently guide and manage its work. This process allowed for continued internal analysis to redefine its lines of work and seek impact, based on the objective proposed in the founding Bylaws.

The establishment of this strategic plan marks the beginning of a new phase, coinciding with the development of a line of work that emerged from the experience of the COVID-19 pandemic and the need to address irrigation management from a humanitarian perspective, marking steps toward resilience.

The pandemic did not prevent the organization from continuing its work; it was used to grow as an organization and innovate in its fundraising efforts, which has allowed it to increase its budget.

The AMA Association is currently recognized locally, departmentally, nationally, and internationally as a dynamic local organization, with young, committed, genuine, and bilingual staff working for adolescent girls and young women in southeastern Petén, a sector experiencing significant demand due to insufficient government support. It is recognized as an organization that promotes gender equality through the empowerment of adolescent girls and young women and is seen as a support entity for government institutions working on this issue. It is perhaps the youngest organization, which in just a few years has managed to establish itself as a benchmark organization on this topic. This positioning led to them hosting the Guatemalan Human Rights Ombudsman and the Vice President of the Republic in 2021 during a visit to the department of Petén.

AMA has fostered changes in its work methodology to address the needs of the youth sector. Previously, dates related to gender equality and violence were commemorated through activist marches. However, these actions have now evolved toward the promotion and development of more critical events such as forums. Previous activities provided a presence but lacked impact; now, reflection is encouraged to influence changes in mindsets and behavior.

The Association carries out recreational activities to communicate and inform through sports, radio, and social media, innovating to reach its target audience, which sets it apart from other organizations working on youth and gender issues. This methodology is complemented by the work it does to promote access to knowledge through the cascade technique, which is developed by training teachers and healthcare workers, reaching a larger population, creating its own content, and strengthening its identity as a local organization.

AMA has established itself as a link between government institutions and the population on issues related to youth and sexual or gender-based violence. This has allowed them to carry out advocacy processes to institutionalize the commitments made, for example, in the Letter of Agreement "Prevent with Education" signed in 2016 between the Ministry of Health and Social Assistance (MSPAS) and the Ministry of Education (MINEDUC), updated in 2020 and valid until 2025. This is an Inter-institutional Cooperation Agreement between both institutions in which commitments were established to include Comprehensive Sexuality Education in school programs, but it was necessary to socialize them and seek their implementation in the department of Petén.

The Association adopted the precepts of the Charter of Agreement, successfully influencing its implementation in the department of Petén through the establishment of the "Prevent with Education" technical panel, comprised of MINEDUC, the MSPAS, and the Association. This panel has successfully secured MINEDUC's ownership of a diploma in Comprehensive Sexuality Education and Violence Prevention that the AMA Association had been developing. This diploma trains teachers to educate their students on comprehensive sexuality education and violence prevention. These activities are contemplated in the Charter of Agreement, but not implemented by MINEDUC.

To ensure that this diploma program could continue to be offered online during the pandemic, in 2020 AMA offered a course to MINEDUC advisors at the departmental level to teach them how to use digital platforms. As a result of the teacher training process through the diploma program, which began in 2016, the percentage of schools where Comprehensive Sexuality and Violence Prevention Education is taught has risen from 0% to 28% in the southeastern subregion of the department of Petén, a figure that is increasing throughout the department as MINEDUC has expanded teacher training. The MINEDUC's General Directorate of Accreditation and Certification certified AMA in the Comprehensive Sexuality Education program for a five-year period. In addition, AMA has ratified an agreement with the Ministry of Education to carry out joint work.

The presidency and legal representation of the AMA Association is exercised by MARIA NEJIA MEJIA CASTELLANOS, according to the appointment dated January 7, 2025, a position accredited according to the registration before the Registry of Legal Entities of the Ministry of the Interior of Guatemala under item four hundred twenty-one (421), folio four hundred twenty-one (421) of book one hundred twentyfour (124) of Appointments.

The AMA Association's vision is: Girls, adolescents, and young women in Petén, Guatemala, understand, demand, and promote their rights and those of others through their leadership, self-esteem, and confidence.

And its mission: To strengthen the leadership of girls, adolescents, and young women in Petén, Guatemala, through educational processes and advocacy to prevent early pregnancies and gender-based violence. Its office is located at Calzada 25 Junio 8028, Zone 4, El Porvenir neighborhood, Poptún municipality, Petén department, Guatemala.
